#### Why are you interested in serving on the Board of Directors?

The experience of my first two-year term has provided the foundation and understanding of Board operations and dynamics in addition to the level of commitment required to achieve Board, and ultimately Academy, directives.

I am the proud parent of two Gryphons (class of 2026 and 2027) and am interested in helping Eagle Ridge Academy continue to strive to develop knowledgeable and engaged citizens that are prepared for their role in the world.

#### What personal qualities, experience, and expertise would you bring to the Board?

I possess two years of experience of serving on the Eagle Ridge Board of Directors with expertise in the areas of real estate and finance. I have been involved in real estate for over 23 years as an appraiser in both the commercial and residential sectors. The majority of my real estate career has been at financial institutions serving in an advisory or review role. Other initiatives or accomplishments achieved during my first term include leading the effort to install monitors around the campus as communication tools for students, staff, and the community, serving as the Election Coordinator for the 2023 school board election, scheduling legislator visits, and collaborating on the Eagle Ridge Academy Strategic Plan. I also volunteer as a coach for the volleyball program in the summer and for various activities during the year.

#### What aspects of Eagle Ridge Academy do you think are the most important to maintain?

In my opinion, the most important aspects for Eagle Ridge Academy to maintain are keeping a focus on its classical education foundation, continue to aspire to high academic standards, and strive to challenge our students to be and give their best while focusing on Eagle Ridge Academy's CIPHER pillars.

What issues need to be addressed by the Board of Directors in the next few years?



The issues the Board of Directors will need to address are discipline issues that continue to increase, the organic growth of the student body that will put pressure on existing facilities, expansion potential as laid out in the strategic plan, teacher and staff retention, tightening financial conditions, and navigating any new legislation.

The organic growth mentioned, and as evidenced by our waitlist for the School of Grammar and School of Logic, requires ERA to make a concerted effort to devote more time and resources to the School of Rhetoric. This investment will yield the benefits of having students who are steeped in the culture of Eagle Ridge Academy stay further enhancing the ERA culture rather than take their skills rooted in classical education to other schools where they will succeed and positively contribute to that community.

#### How would you evaluate if Eagle Ridge Academy is delivering its intended mission?

Student achievement is standard and worthy metric but should be incorporated with the impact is having on Academy stakeholders; students, teachers, parents, staff, and administration as ERA attempts to deliver its intended mission. A recommendation of another serving Board member of how to measure this impact would be the achievement of our graduates' and their attitude towards the education they received at ERA, the amount of school pride; a desire to recommend ERA to others, and a desire to give back to ERA through volunteering, tutoring, donating, mentoring, or teaching. These items may not be able to be measured but would seem to be visible or able to be experienced by the ERA community.

# How would you weigh the input from parents, students, teachers, and the Administration in making Board decisions?

Input from parents, students, teachers, and the administration is critical to the success of Eagle Ridge Academy. Part of the uniqueness of Eagle Ridge Academy is that most, if not all, of the families at ERA have done so intentionally. This intention fosters a special culture, but it also requires additional engagement. Unfortunately, during my two-year term, there has been few, if any, instances where a community member attended and contributed to a Board of Directors meeting in person. While this could be interpreted as good sign, I would strongly encourage parents, students, teachers and staff to attend Board meetings to bring attention to issues the Board should weigh and consider. An active community is an asset that will benefit the Board and the Academy as a whole.

For any organization, the board should always be addressing financial stability, long range strategic planning, oversight of the Executive Director, policy reviews/updates, and ensuring alignment to the mission/vision.

#### How would you evaluate if Eagle Ridge Academy is delivering its intended mission?

There are multiple ways to evaluate how well ERA is delivering on its mission - some are objective measures while others will be more subjective. Student test scores provide one benchmark of academic achievement. Disciplinary actions provide a benchmark of honorable character. Less objective measures include ensuring the education is "Classical" and watching to see if our students do indeed "attain their highest potential." Student retention provides a lens to let us know whether or not students are engaged enough to return year after year.



# How would you weigh the input from parents, students, teachers, and the Administration in making Board decisions?

Parents, students, teachers, and the administration are all vital members of the community. I believe there is an art to ensuring all voices are heard, while, at the same time, ensuring the right governance decisions are still being made by the right people, at the right time, and in the right way. All of us come to the table with different information and backgrounds - being heard is important - but ultimately, board decisions need to be made by the board, after hearing relevant input from impacted stakeholders.
